Final Instructions

Start:- First bike 10.30 am All riders will start at section 1 Thereafter at 1 minute intervals.

Signing On:- Opens at 9am

Scrutineering:- 9.00- 10 am

Parents/Guardians and Assistants must sign on to collect their punch cards, bibs and bike numbers, prior to scrutineering. All competitors riding combustion engine machines must have cut out devices rigidly connected to the rider by a lanyard (max length 1 metre) so as to stop the engine should the rider and machine be parted.

Observers Briefing: 10.00 am Prompt In Scrutineering Area

Course: - 3 Laps Of 12 Sections, approximate length of course 1 mile

Class C standard wheel will ride ROUTE 1 follow Red and Blue flags

Class C medium wheel will ride 50% ROUTE 1 and 50% ROUTE 2

Class D medium wheel will ride ROUTE 2 follow Yellow Flags

Class D small wheel will ride ROUTE 3 follow White Flags

Class D - Small Wheel, Combustion Engine will ride ROUTE 3 follow White Flags

Please keep to the marked route between sections,

The assistant will only be allowed into the boundaries of the section if their rider is in the section when invited by the official. Parents / assistants found riding machines on the course will have their charges excluded.

OVERALL TIME ALLOWANCE.

The individual time allowance will be displayed at the Start of the Trial The Time Control will be located immediately after the final section. The rider is obliged to go directly from the Final Time Control to the Results Recorder. Any rider who delays the publication of a result will be reported to the Stewards of the Meeting for disciplinary action.

PROTESTS. Protests must be made within 30 minutes of the publication of the results on the Scoreboard displayed at the event.

General: Overnight camping is available in the field with toilets, please bring your own water.

Awards will be presented as soon as possible after the event.
