ANNOUNCEMENT: - Richmond Motor Club (Yorks) Ltd. will organise a Centre Restricted Trial on Sunday 17th September 2017 for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting which will be displayed at the start. (This event will count towards the Yorkshire Centre Championships)

ELIGIBILITY: - Restricted to registered members of Yorkshire Centre ACU Clubs. All riders and passengers must hold a current ACU / SACU Trials Registration card or ACU/SACU competition licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

CLASSES: - Championship Course: Adult: Expert; Intermediate; Novice. Youth: A Class

Clubman A Course: Adult: O45Expert; O45Intermedite; Novice. Youth: B Class

Clubman B Course: Adult: Novice.

None Competitive: Participants may ride other courses on a non competitive basis.

* Note there will be no Youth C Class, as the venue is not suitable. Youth riders must ride their correct age class.

START: - 10.30 a.m. (The start area will be silent). Refreshments will be available at the start.

ENTRIES: - On the completed form provided along with the correct fee of £20.00 adults or £10 youth to the Secretary of the Meeting by closing date of Saturday 16th September 2017, or up to 1 hour before the start. (Make cheques / money orders payable to Richmond Motor Club (Yorks) Ltd.) * NO TELEPHONE ENTRIES WILL BE ACCEPTED.

RESULTS: Will be posted on the club website. Those wanting hard copies must provide a SAE envelope with entry.

AWARDS: - Best Performance: The G E Brown Trophy* and an award.

Awards to next 5% of finishers in each class. (Subject to a min. entry in class).

*(Trophies to be held for one year only).

COURSE: - All on private land and shall consist of 2 laps of 20 sections, (weather dependent to be confirmed on the day of the trial). Sections shall be ridden in correct order on each lap. Note that the terrain at this venue can be testing. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed

METHOD of MARKING: - As per TSR 22b; no stop. Ties will be resolved as per TSR 23

PROTESTS: - as per the National Sporting Code of the ACU, section 10.04

GENERAL: - Dogs allowed; but must be kept on a lead at all times.

Richmond Motor Club forbid the wearing of cameras on any part of the body or machine whilst competing in a Richmond Motor Club Event. This decision comes following a number of accidents in which the wearing of a camera has caused injury. The decision was also made as it was considered that when helmet mounted there was also a risk of damaging the integrity of the helmet.
