All riders must keep to the marked route AT ALL TIMES. This is not negotiable and MUST be adhered to be granted the permissions that we need from Yorkshire Dales National Parks, (YDNP). SHOULD ANY RIDER BE FOUND TO DELIBERATLEY FLOUT THIS RULE, they will be DISQUALIFIED from the trial immediately. In addition, the YDNP will be at the event monitoring problem areas. Should proven evidence be presented to the Committee at any time including after the results have been published and/or awards been presented, any offending participant will have any awards received rescinded.

The wearing of cameras on any part of the body or machine whilst competing in The Scott Trial is forbidden. This also includes Helmet Cameras, both intrinsic and mounted.

There have been issues over recent years with riders and support teams accessing the Scott course in increasing numbers the weeks before the trial. This has included access to the moors during grouse shoots which both endangers life and future access for the Scott. There are large parts of the course which the club only has permission from the owners to use for marking out and on the day of the event. Therefore, if any rider, or member of a rider's team, is caught on private land without permission, they risk being excluded from the trial. Please help us to keep our landowners & gamekeepers happy – without them there will be no Scott!
